

Said two kinds of improvement being as follows, to-wit:

IMPROVEMENT NO. 1. The street shall be brought to subgrade between the curb lines of said street, from the south side of Fourth Street to the south side of Fourteenth Street. On the road bed shall be placed a 2 inch asphaltic concrete wearing surface. Said street, where required shall be provided with 6 ft. concrete walks and standard concrete curbs 6 x 8 x 18 inches on each side of said street.

The street shall be properly provided with drains and gutters necessary to provide proper drainage for the street.

All of said improvement shall be made according to the plans and specifications which are hereby referred to and made a part of this resolution, and which were filed on the 17th day of May, 1927, in the office of the City Recorder and which plans and specifications are hereby approved.

The improvement shall be classed as asphaltic concrete and shall be maintained by the city for the full period of ten years from the date of the acceptance thereof by the city commission.

IMPROVEMENT NO. 2. The street shall be brought to subgrade between the curb lines of said street, from the south side of Fourth Street to the south side of Fourteenth Street. On the road bed shall be placed 6 inches of Concrete. Said street, where required, shall be provided with 6 ft. concrete walks and standard concrete curbs 6 x 8 x 18 inches on each side of said street.

The street shall be properly provided with drains and gutters necessary to provide proper drainage for the street.

All of said improvement shall be made according to the plans and specifications which are hereby approved.


The improvement shall be classed as concrete and shall be maintained by the City for the full period of ten years from the date of the acceptance thereof by the City Commission.

The City Recorder is hereby instructed to cause this resolution to be published according to the City Charter and to give notice of publication for not less than five days in a newspaper published and of general circulation in Oregon City inviting bids for each kind of improvement provided for in this resolution.

Passed at a special meeting of the City Commission held on the 18th day of May, 1927.

Special Meeting

The City Commission of Oregon City, Oregon met in special session on the above date in the office of the City Manager at the hour of one o'clock p.m.

Roll Call showed the following present : Pave and Farr commissioners and City Manager Franzen.

The minutes of the previous meeting were read and approved.

Ordinance No. 1152 was read second time and placed on its final passage. The title of the ordinance being an ordinance

authorizing the Mayor and City Recorder of Oregon City, Oregon, to execute a Boundary Line Deed establishing the boundary line of Elevator Street through Block 34, Of Oregon City, Oregon.

Ordinance No. 1153 was read first time and ordered published.

ORDINANCE NO. 1153

An ordinance declaring the assessment for the cost of Sewer District No. 20.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. The assessments for the cost of Sewer District No. 20 has been levied and declared according to the assessment roll. Sewer District No. 20 Assessment Roll No. 1927 "B" and the whole cost thereof is \$551.34.

Sec. 2. Whereas, the territory embraced by the proposed district is thickly settled, and was without proper sewerage and drainage, which was a menace to the health and safety of that district and the people of Oregon City, and is necessary for the immediate protection of the health and safety of the people of that district and Oregon City, that said proposed sewer was constructed

An emergency is hereby declared to exist and this ordinance shall take effect and be in force immediately upon its approval by the mayor.

Read first time and ordered published at a special meeting of the City Commission held on the 23rd day of May, 1927, and to come up for second reading and final passage at a Regular meeting to be held on June 1, 1927 at the hour of Two o'clock p.m.

The following Resolution adopting the ballot Title for the proposed amendment to the Charter to come up before the voters on June 28th, was read and adopted.

RESOLUTION

Whereas, the City Commission of Oregon City has submitted to the people of Oregon City for their adoption or rejection an amendment to the Charter of Oregon City to be voted upon at the Special City Election to be held on the 28th day of June, 1927, and

Whereas, the City Attorney, on the 17th day of May, 1927 filed with the City Recorder a ballot title for said charter amendment, and

Whereas, no objections to said ballot title have been filed by any person.

Therefore Be It Resolved by the City Commission of Oregon City that the said Ballot Title prepared by the City Attorney of Oregon City be, and the same hereby is approved.


The Ballot Title being as follows, to-wit:

"A Bill for an Act to amend Section thirty-two (32) of the Charter of Oregon City, providing for the election of three commissioners, one for six years, one for four years, one for two years, Thereafter at each regular election one commissioner to be elected for six years."

Adopted this 23rd day of May, 1927.

Ordinance No. 1151 was considered and on motion the second reading and final passage was postponed until the meeting to be held on June 1st.
