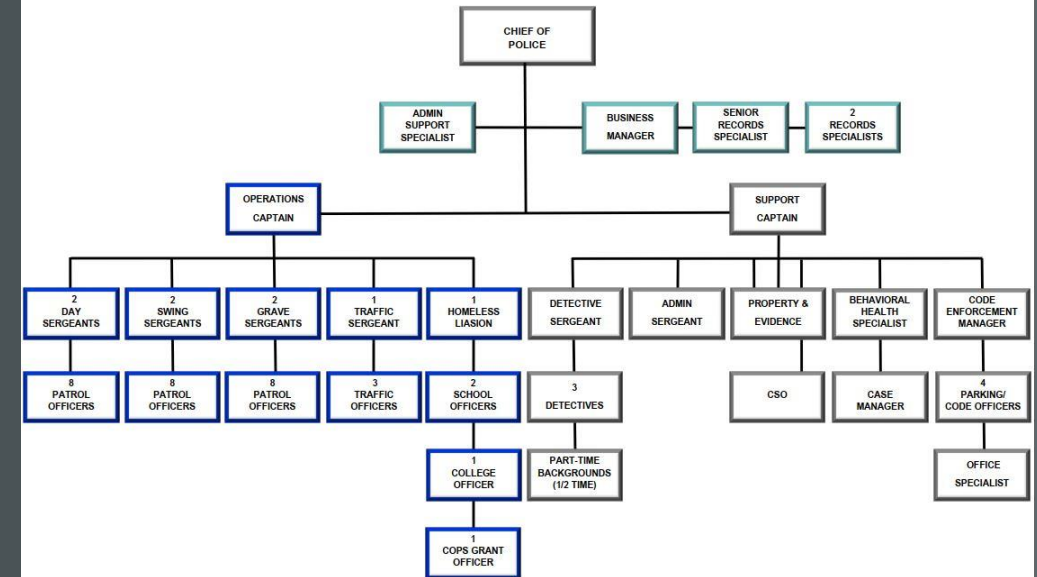

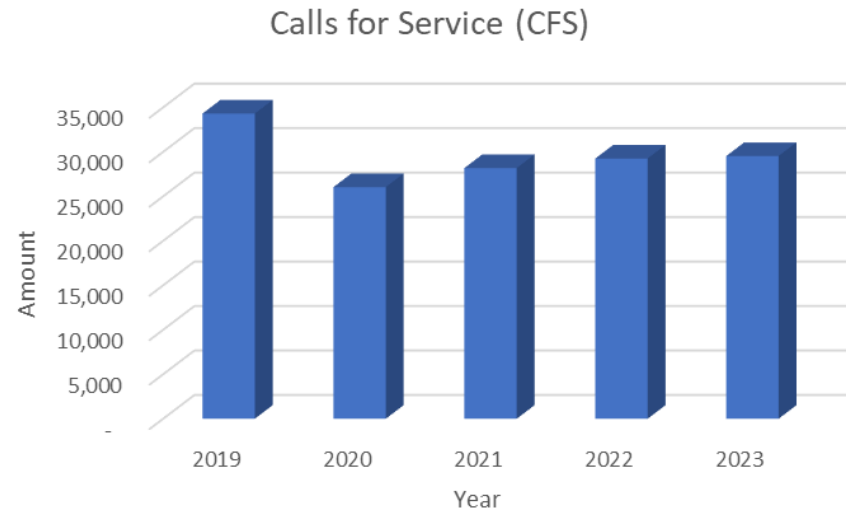

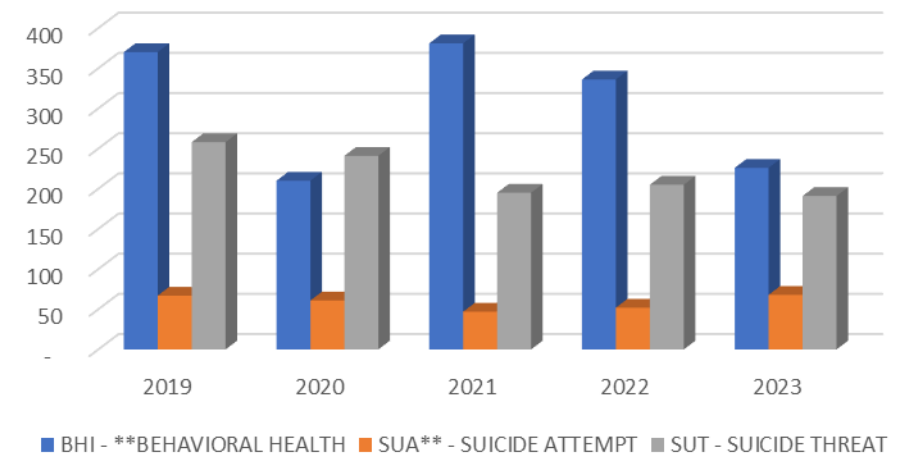

Statistical Transparency of Policing –

The STOP program stems from the 2017 Oregon Legislative Session, where HB 2355 was enacted and signed into law. The bill requires:

All Oregon Law Enforcement Agencies (LEAs) to collect specific data related to officer-initiated traffic and pedestrian stops.

Oregon State Police (OSP), in consultation with the Criminal Justice Commission (CJC) and the Department of Justice (DOJ), to establish a standardized method for the collection of required data elements from all Oregon LEAs.

CJC to perform the requisite data analysis to identify patterns and practices and profiling and deliver a report to DPSST to provide advice or technical assistance based on the best practices of policing to LEAs.

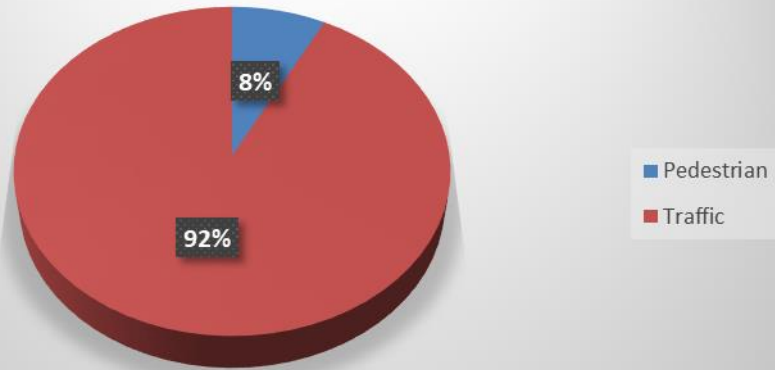

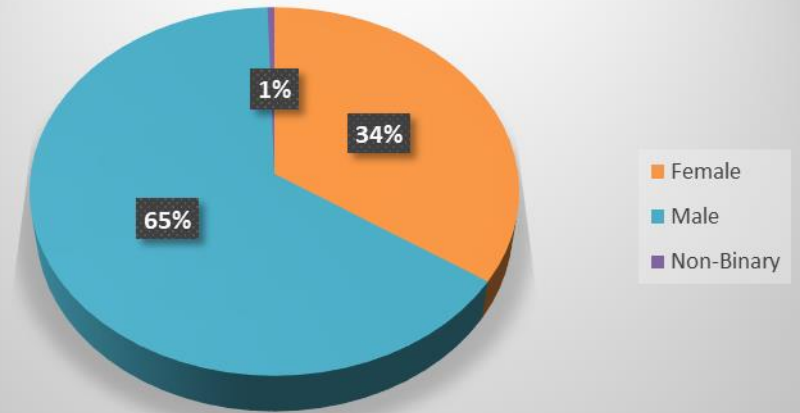

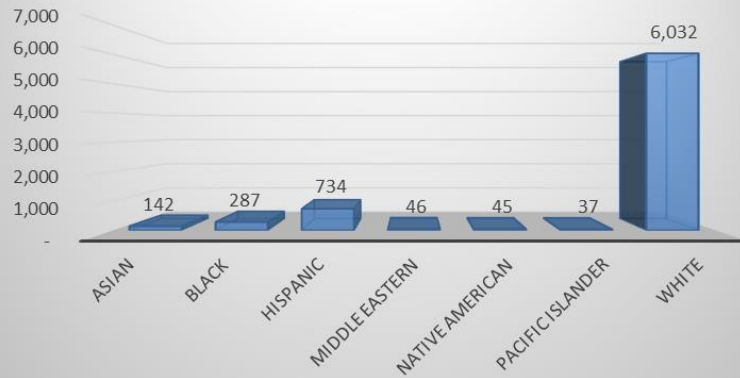

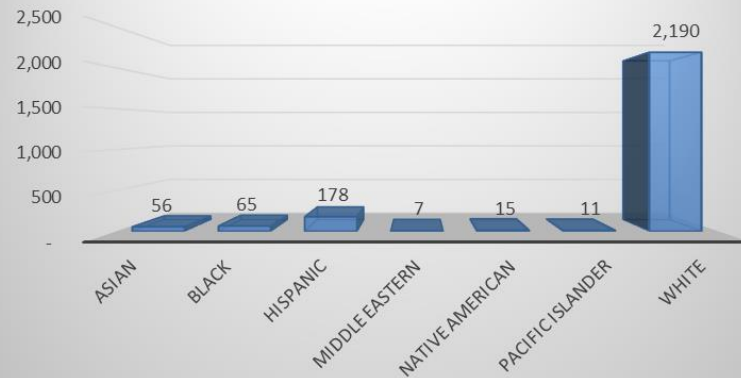

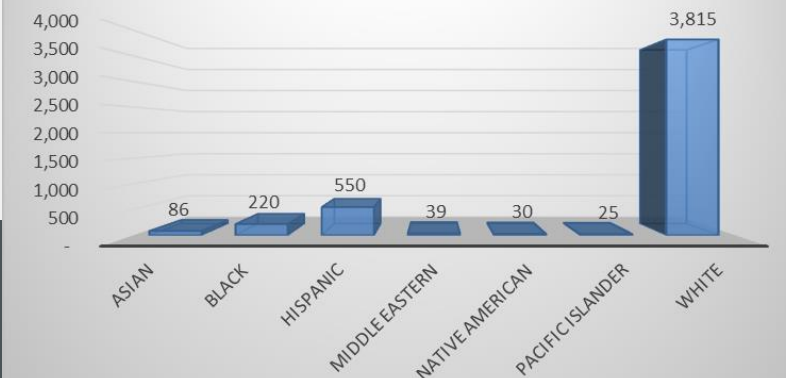
STOP's by Race / Ethnicity

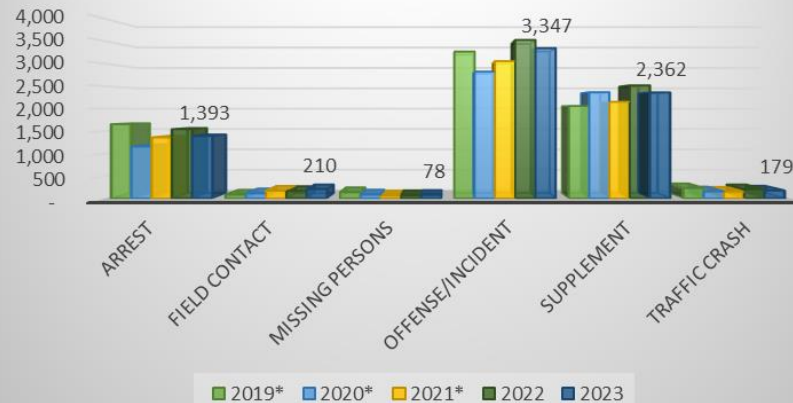

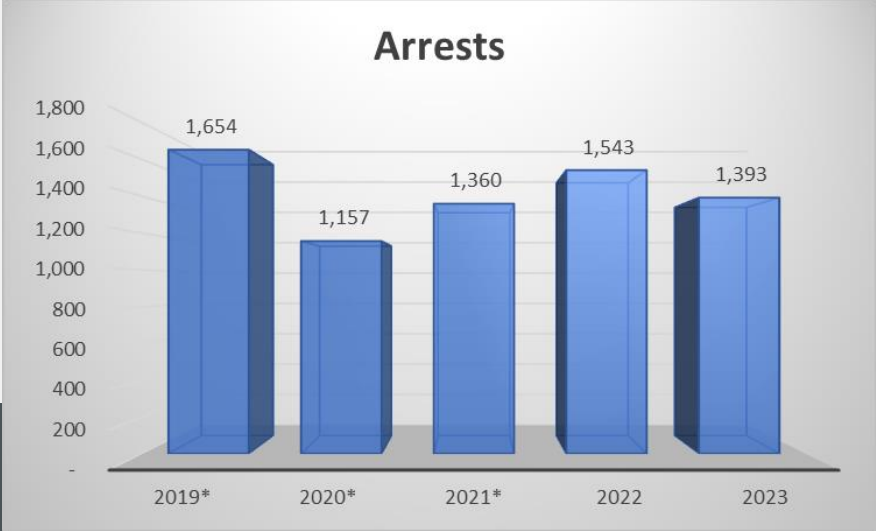

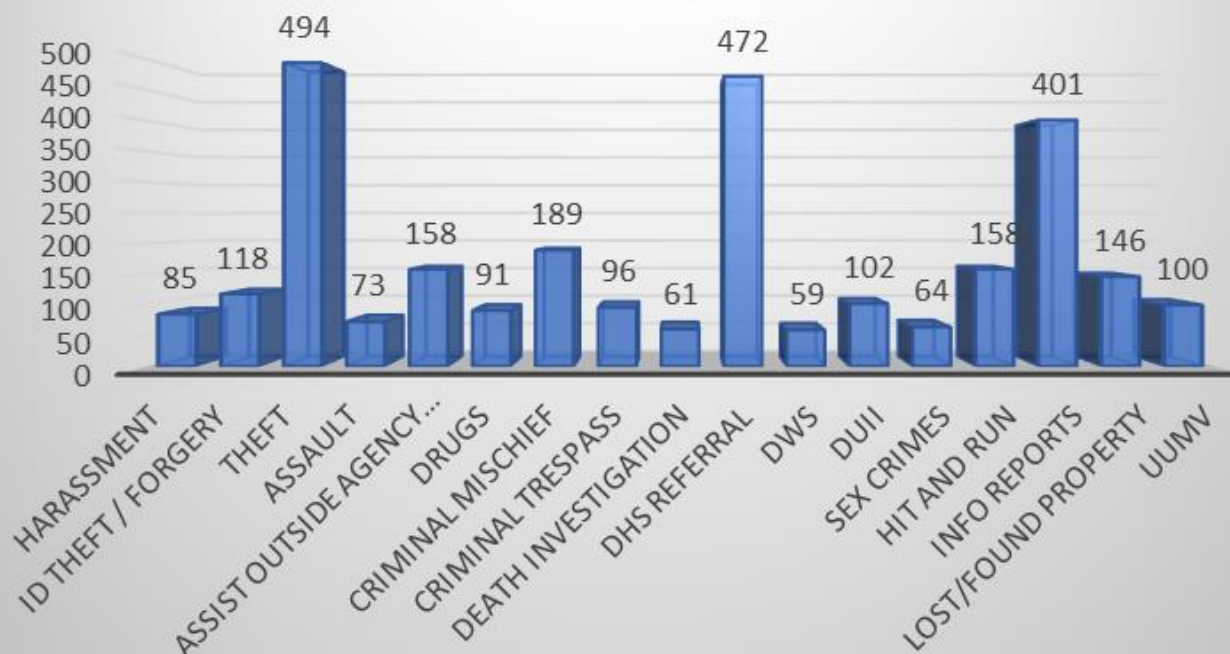

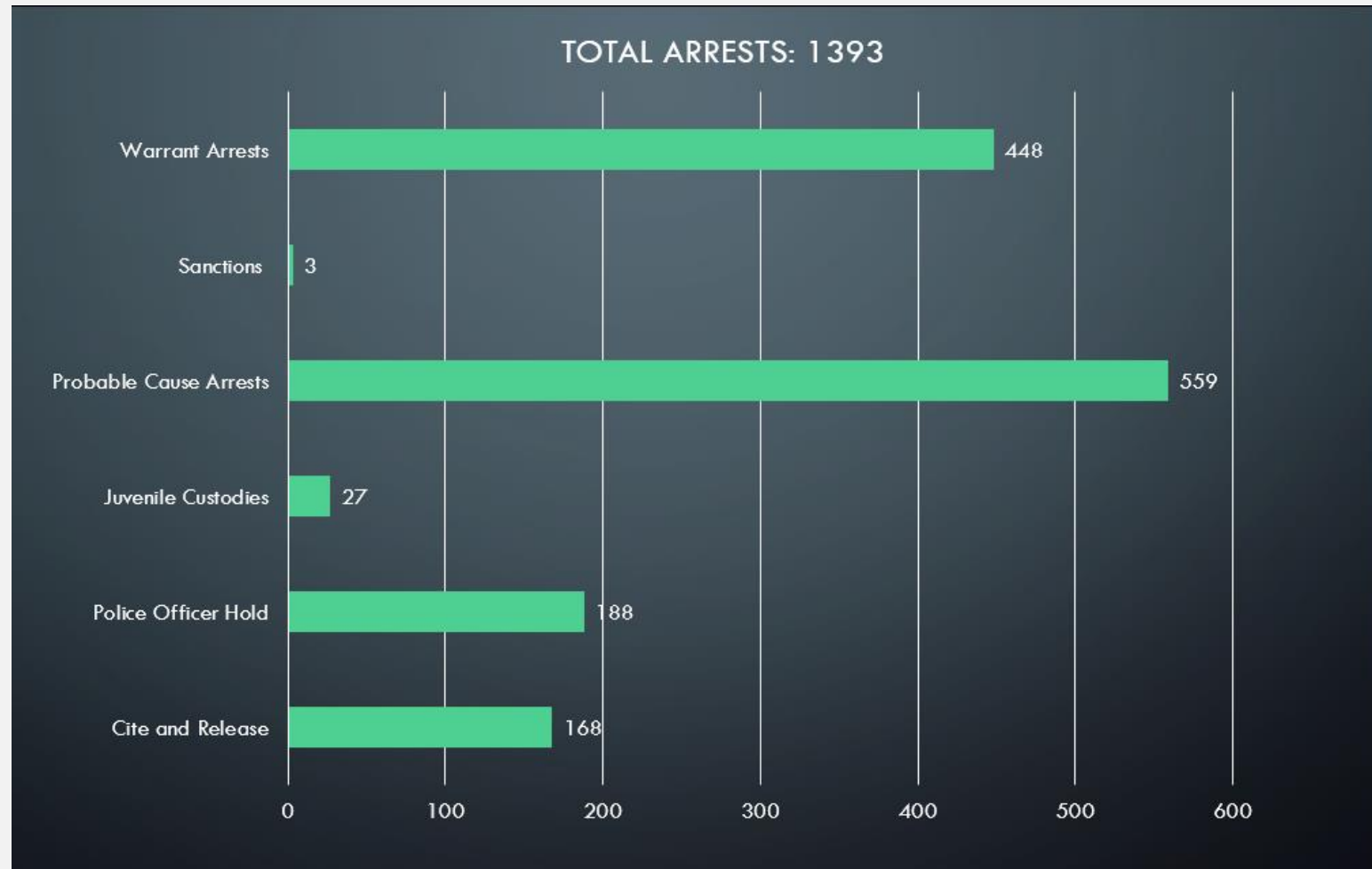

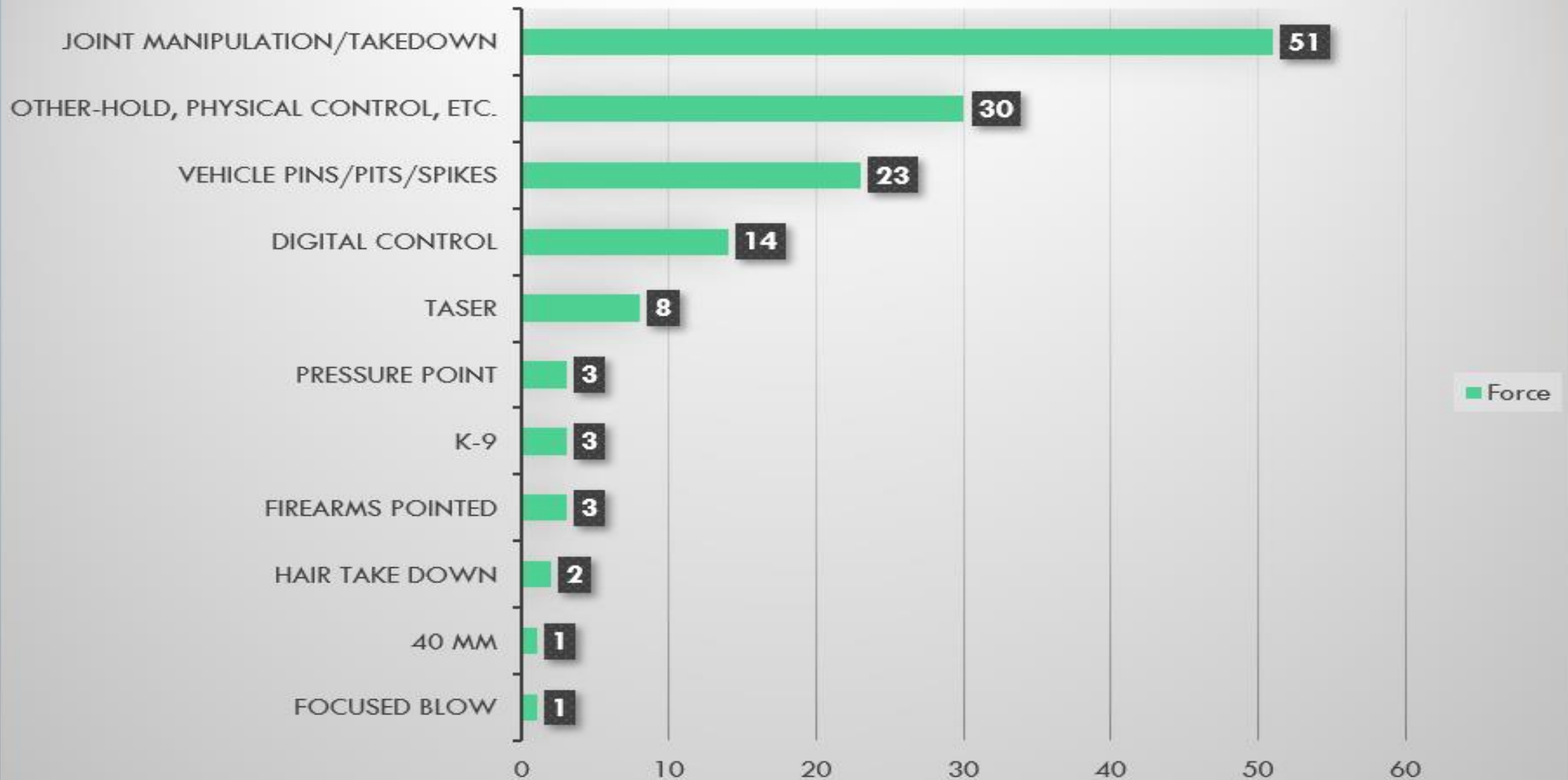


SUMMARY OF USE OF FORCE INCIDENTS 2023

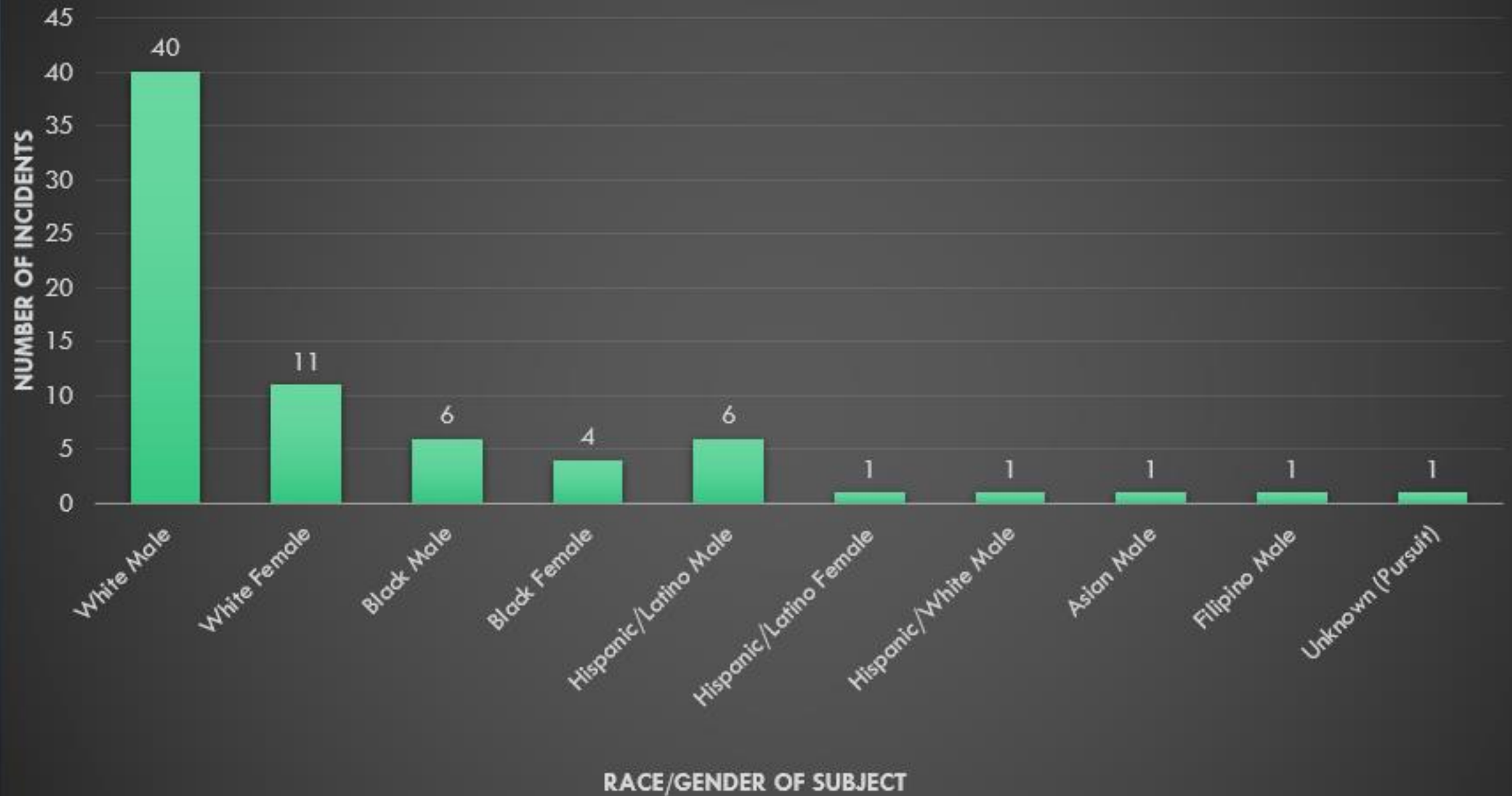
- 70 Incidents documented (72 individuals)
- 125 Individual UOF reports
- 17 were vehicle related (9 PIT/PIN (6 total incidents), 14 Spikes (11 total Incidents))
- Force was used in 5.03% of arrests (which includes vehicle related interventions, such as PIT's/PINS), when vehicle interventions are removed force used was 3.8% percent of arrests

CODE ENFORCEMENT

- Additional Code Compliance Officer added as part of 2023-2024 Budget
- Code Enforcement now offering 7-day coverage
- Three Code Officers were hired and began field training in 2023.



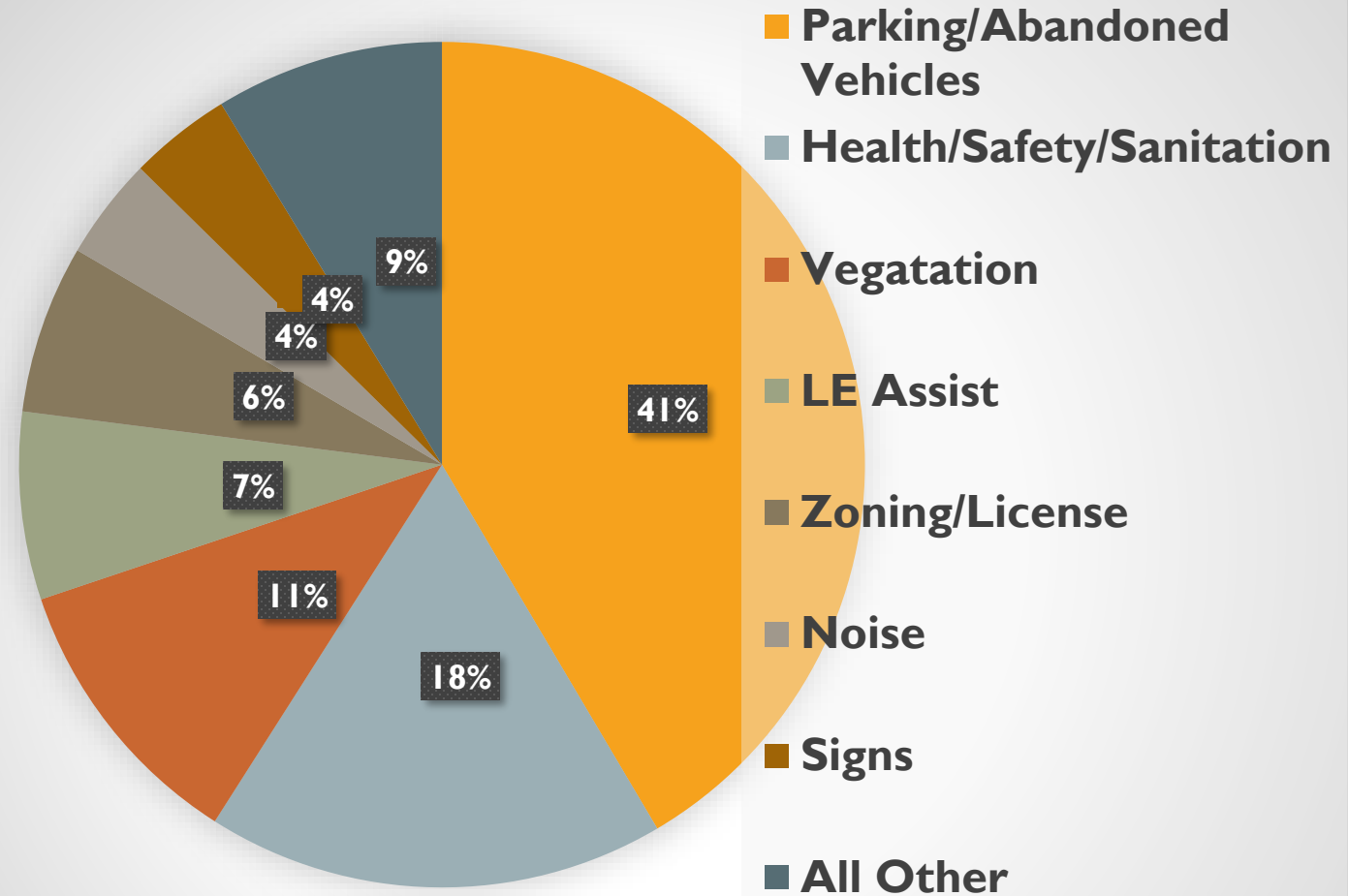
CODE DAILY OPERATIONS

KEEPING OREGON CITY CLEAN PROJECT

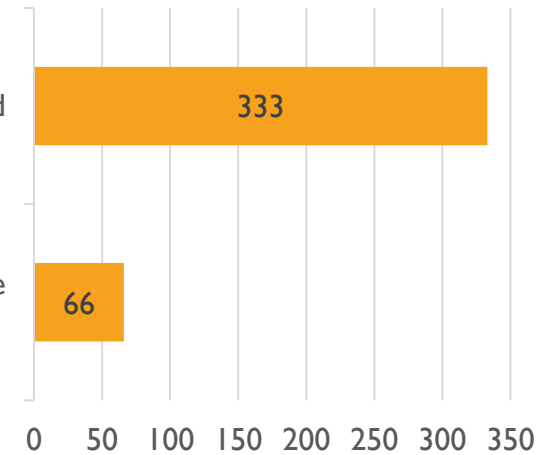
- Initiated in April of 2023

Shopping Carts Removed



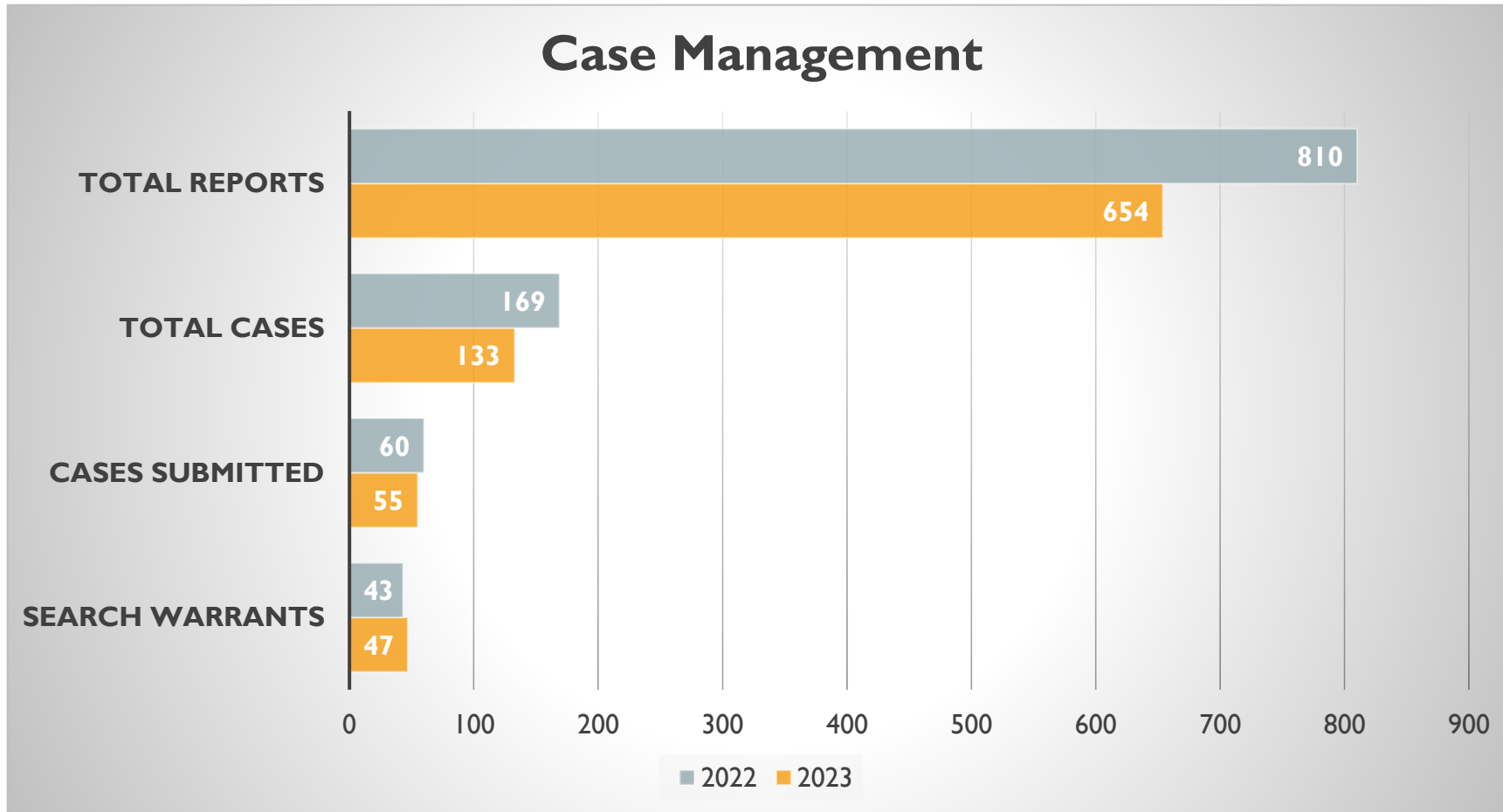
Bags of Garbage/Refuse

DETECTIVE DIVISION

- Consists of 3 full-time Detectives and 1 Detective Sergeant
- Detectives work as part of the Clackamas County Major Crimes Team in conjunction with the District Attorney's office
- Detectives work on-call and are available 24/7



DETECTIVE YEAR IN REVIEW

DETECTIVE NOTABLE INVESTIGATIONS

- Three separate homicides occurred within the City of Oregon City, accounting for 25% of the total number of homicides in Clackamas County.



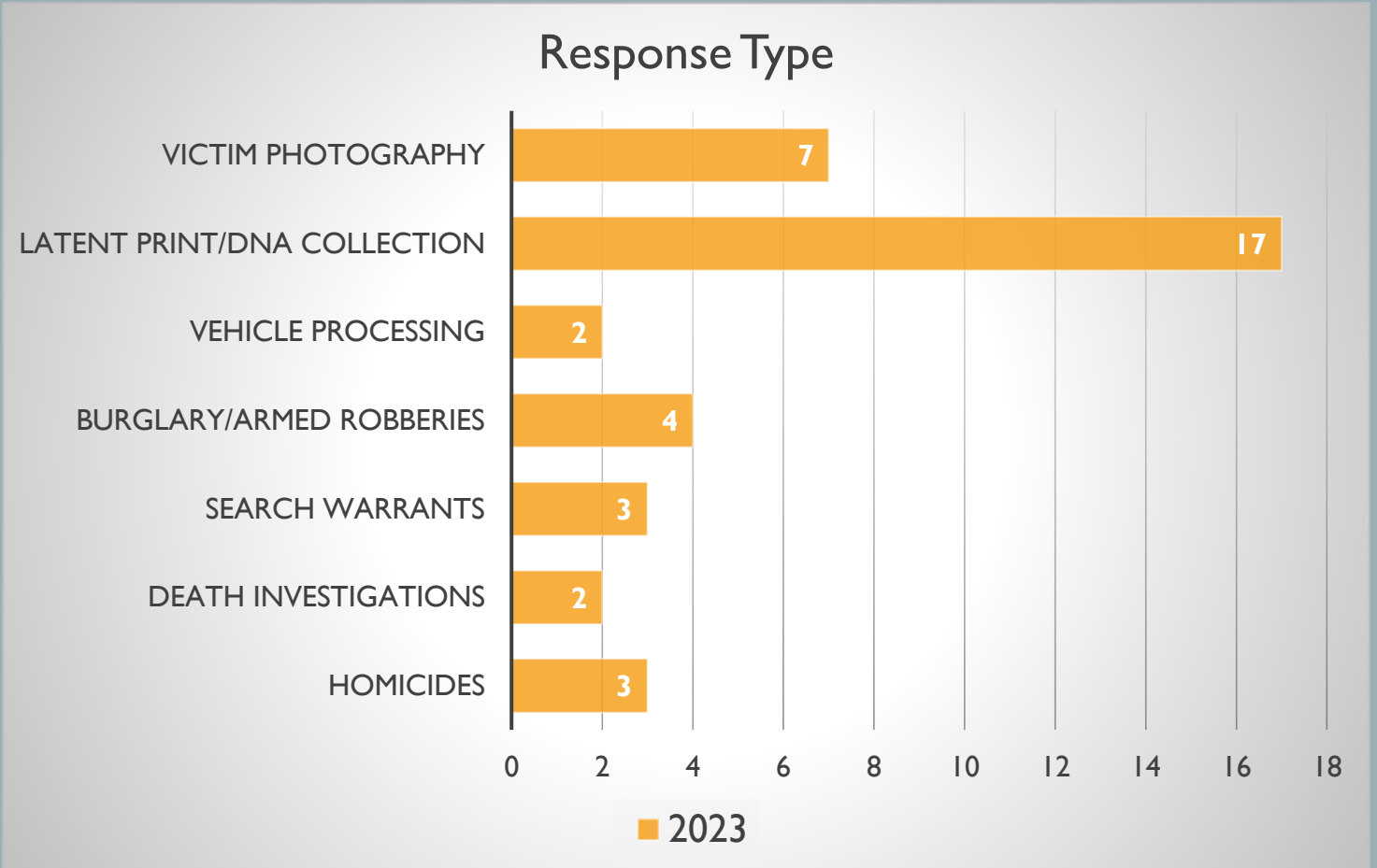
DETECTIVE SUPPLEMENTAL DUTIES

CRIME SCENE PROCESSING & FORENSICS



SPECIAL INVESTIGATIONS TEAM

- Comprised of 8 officers and 2 sergeants.
- 2023: 31 Missions resulting in 14 Custodies (10 OC Residents)
- 7 Search Warrants
- 3 Chronic Nuisance Properties
- Total fentanyl seized: 55,398 fentanyl pills seized (5,539 grams) and 10,427 grams of fentanyl powder seized
- 2 milligrams of fentanyl is considered a lethal dose.

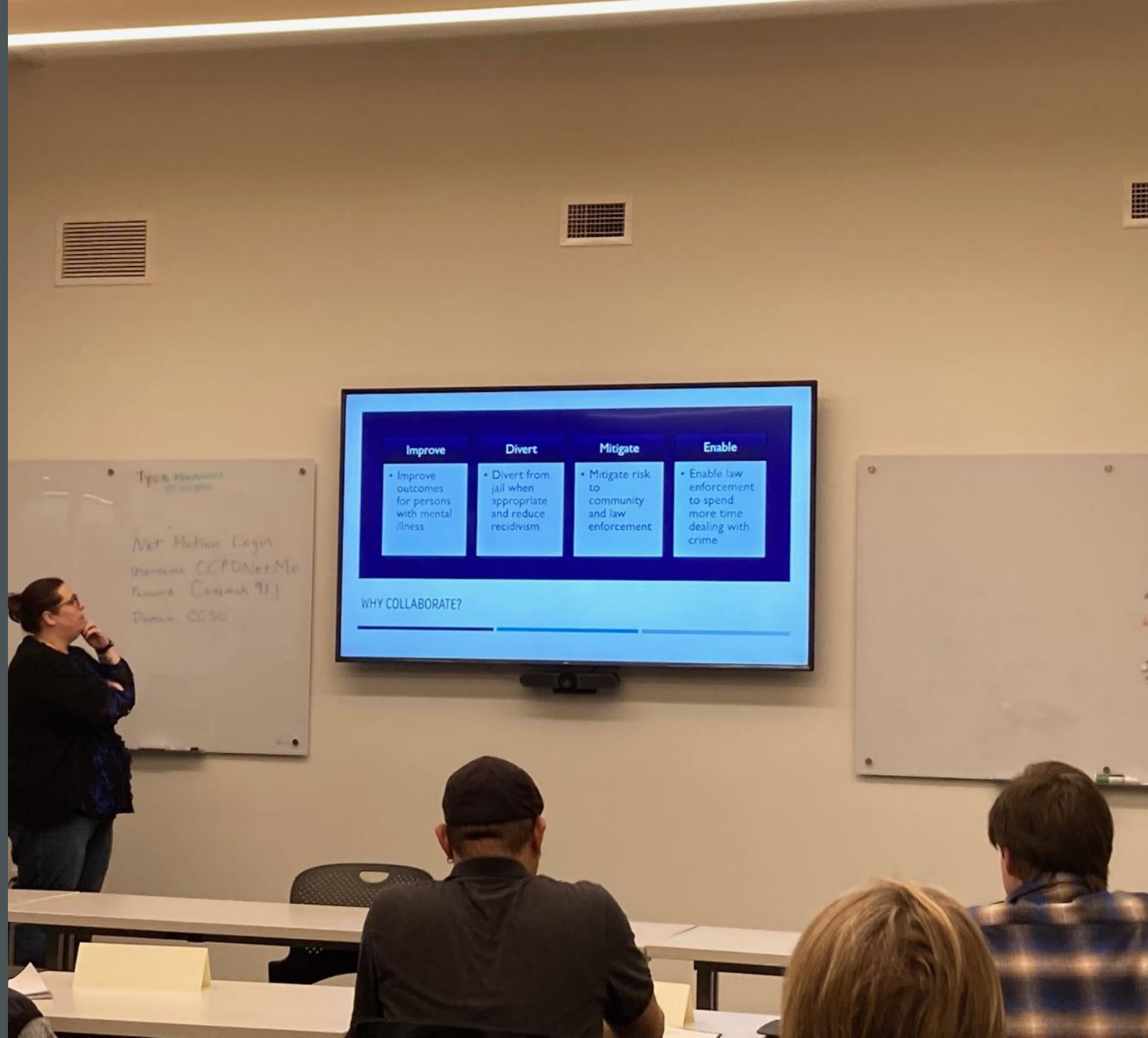

BHU TRAINING & REFERRALS

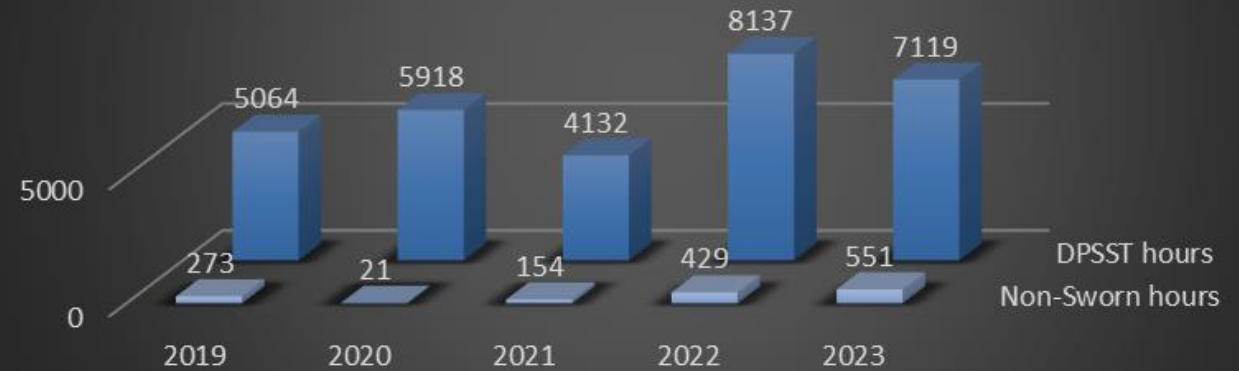
- BHU accounted for 21 separate trainings to OCPD, city staff, and other community partners
- 532 total referrals made to BHU
 - Over 42% increase from 2022
 - 163 in-person outreach
 - 70% related to homelessness

HOMELESS LIAISON OFFICER

- Monthly coordination meetings with community stakeholders
- Fields complaints regarding livability issues
- Versed in current case law, restrictions, and social programs



NEWELL CREEK CANYON CAMP CLEANUP

- 7-day notice given to all occupants
 - 34 illegal camps located
- Items removed include hazardous materials, drug paraphernalia, human waste, physical hazards, and personal property



TRAFFIC TEAM

- Comprised of 3 traffic officers, 1 traffic sergeant when fully staffed.
- 2,522 traffic violations were enforced through written warnings or citations.
- Responded to 348 traffic crashes agency-wide
- Participates in four separate grants from ODOT.
- Participated in 14 inter-agency monthly traffic missions.



COMMUNITY EVENTS



OCPD SUMMER CAMP

- Weeklong event, which is ran by the school resource officer.
- Approximately 30 grade school-aged students from OCSD.
- Field Trips (Oaks Park, Bowling)
- Guest Speakers: K9 Officers, Drone Operators, SWAT Operators, Clackamas County Fire Dept.



CITIZENS ACADEMY

- The Oregon City Citizens Police Academy is a free 10-week course with a mission to familiarize citizens with the operations of the police department and the professionals behind the badge.
- Topics may include patrol procedures, criminal law, narcotics, search and seizure, tactical operations, investigations, firearms demonstrations, use of force issues, and police canine demonstrations.



PRESCRIPTION DRUG TAKE BACK EVENTS

- OCPD partners with the Drug Enforcement Administration (DEA) and hosts (2) Drug Take Back events each year: April & October.
- The department also maintains a drug collection box, available to the public, to turn in unwanted prescription drugs during normal business hours.



WOMEN'S SELF DEFENSE CLASSES

- OCPD Defensive Tactics Instructors taught (4) Free Women's Self Defense classes in 2023 with 50 participants.
- Classes are hosted onsite at OCPD and are very popular within in the community.



NATIONAL NIGHT OUT

- National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie.
- OCPD coordinates the event and invites city departments and Neighborhood Associations to participate with informational booths and activities.
- Local businesses like Oregon City Grocery Outlet and Fred Meyer donate food and beverages for the more than 500 annual visitors.



TRICK OR TREAT MAIN STREET

- Each year OCPD participates in the Downtown City of Oregon City's Trick or Treat on Main Street event.
- This event is a great opportunity to honor Fallen Officer Rob Libke while connecting with the community.



AGENCY ACCREDITATION

- OCPD was the first agency in Clackamas County to become fully accredited on April 20, 2004.
- OCPD passed re-accreditation in 2007, 2010, 2013 2016, 2019, and most recently December 2022 (Awarded at the OACP conference in April).
- Accreditation for law enforcement means policies and procedures are in place and are followed by the men and women of our agency.





REMEMBERING OUR FALLEN

- This was the 10-year anniversary of Officer Robert Libke's EOW
 - Held a public remembrance on November 3, 2023



FUTURE CHALLENGES:

- Succession planning
 - 7 sworn that can retire within the next 3 years.
 - 4 of those positions are in leadership positions
- Hiring & Retention
- The continual evolution of policing.
- Meeting the changing needs of this City.
 - Growth of the City
