

Agency Organizational Chart




As of January 2025 the Oregon City Police Department consists of 46 sworn personnel and 16.5 non-sworn personnel.





## Statistical Transparency of Policing -


House Bill 2355 (2017) mandates all Oregon law enforcement agencies to submit data regarding officer-initiated traffic and pedestrian stops to the Oregon Criminal Justice Commission (CJC), so the CJC can analyze the submitted data for evidence of racial or ethnic disparities on an annual basis. The Oregon Statistical Transparency of Policing (STOP) Program, housed at the CJC, was created with assistance from the Oregon State Police and the Oregon Department of Public Safety Standards and Training (DPSST). The 2024 STOP's Report, published December 1, 2024, is the sixth annual report to the Oregon Legislature by the STOP Program examining data received pursuant to HB 2355. Data analyzed was from July 1, 2023 to June 30, 2024.


# SUMMARY OF USE OF FORCE INCIDENTS 2024

- **79 Incidents documented (79 individuals)**
- **162 Individual UOF reports**
- **21 were vehicle related (10 PIT/PIN), 11 Spikes**
- **Force was used in 5.65% of arrests (which includes vehicle related interventions, such as PIT's/PINS), when vehicle interventions are removed force used was 4.15% percent of arrests**





## TYPES OF FORCE USED





# DETECTIVE DIVISION

- Consists of 3 full-time Detectives and 1 Detective Sergeant
- Detectives work as part of the Clackamas County Major Crimes Team in conjunction with the District Attorney's office
- Detectives participate in various Multi-Disciplinary Teams, including Child Abuse and Human Trafficking
- Detectives work on-call and are available 24/7

- Anthony Wessel pled guilty in April to murdering his wife, Anna Wessel. (November 2023)




# SPECIAL INVESTIGATIONS TEAM

- Comprised of 8 officers and 2 sergeants.
- 2024: Multiple drug arrests and seizures.
- Two cases involving the crime of Luring a Minor
- Two cases involving the purchase of stolen property
- Over 100 lbs of fentanyl seized

# BHU TRAINING & REFERRALS

- Training
  - 98 hours of training provided
- Referrals
  - 561 police reports reviewed
  - 379 in-person outreach
  - 85% related to homelessness
    - 15% increase from 2023
- Active Crisis Intervention Team (CIT) Clients
  - 58 clients (all are homeless)
    - 52 of the 58 are from Oregon City



# TRAFFIC TEAM

- 4,561 traffic violations were enforced through written warnings or citations.
- Responded to 791 traffic crashes agency-wide
- Participates in four separate grants from ODOT.
- Participated in 10 inter-agency traffic mission details.
- 192 Commercial Motor Vehicle Inspections
- Responded to 208 traffic specific complaints (calls for service)






**TRAFFIC GRANT STATISTICS**

# K-9

- 2 Patrol K-9's (Ronnie & Slate)
- 1 Narcotics K-9
- K9 Coco joined our department in the fall and completed training in December with new handler Ofc. Losli.
- K-9 Slate retired in January 2025
- K9 Grendel unexpectedly passed away 01/05/2025.





## HOMELESS LIAISON OFFICER

- Reallocated to patrol for coverage.
- Continue to have monthly coordination meetings with community stakeholders
- Patrol continue to provide outreach and work with our community partners for resources and housing



## UNAUTHORIZED CAMP CLEANUPS

- Minimum 72-hour notice given to all occupants
- Work with our community partners when posting and before any clean-ups
- Items removed include hazardous materials, drug paraphernalia, human waste, physical hazards, and personal property

# CODE ENFORCEMENT

- Additional Code Compliance Officer added as part of 2023-2024 Budget
- Code Enforcement has 7-day coverage
- One Code Officer was hired and completed field training in 2024




## CODE DAILY OPERATIONS

- Working to keep our city clean.




# CODE CASE TYPE BY CATEGORY

- 2,351 Total cases
- Largest number of cases in past 5 years
- Over 20% increase in cases from 2023



# KEEPING OREGON CITY CLEAN PROJECT

- Initiated in April of 2023
- Cleaning up city streets and right of ways
- Removal of abandoned shopping carts and associated garbage





## COMMUNITY OUTREACH & EVENTS

- OCPD hosts various community events each year including the Citizen's Academy, self defense classes, a youth summer camp, National Night Out, and more.
- Department staff attend events throughout the community to include school functions, parades, movies and concerts in the park, and more.

# OCPD SUMMER CAMP

- Weeklong event, which is ran by the school resource officers.
- Approximately 30 grade school-aged students from OCSD.
- Field Trips (Oaks Park, Bowling)





## CITIZENS ACADEMY

- The Oregon City Citizens Police Academy is a free 10-week course with a mission to familiarize citizens with the operations of the police department and the professionals behind the badge.
- Topics include patrol procedures, criminal law, narcotics, search and seizure, tactical operations, investigations, firearms demonstrations, use of force issues, and police canine demonstrations.



## NATIONAL NIGHT OUT

- National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie.
- OCPD coordinates the event and invites city departments and Neighborhood Associations to participate with informational booths and activities.
- Local businesses like Oregon City Grocery Outlet and Fred Meyer donate food and beverages for the more than 500 annual visitors.



## TRICK OR TREAT MAIN STREET

- Each year OCPD participates in the Downtown City of Oregon City's Trick or Treat on Main Street event.
- This event is a great opportunity to honor Fallen Officer Rob Libke while connecting with the community.
