RE: City Staff Removal of a 24" Alder at the End of the Oregon Trail site

Dear Chris,

On the afternoon of Thursday, June 12, 2025, I visited the End of the Oregon Trail site of the 24" DBH alder tree that you've submitted a City Staff Removal of Significant Public Tree application, as well as Type I Minor Site Plan & Design Review application # **SP-25-00027** regarding.

While inspecting the tree, I was able to confirm that the tree indeed measured 24" in circumference at 54" above grade. I was also able to confirm that the tree appears to be significantly diseased, with a major part of the bark at the trunk having sloughed off, the flesh of the tree exposed and many significant fungi growing around rotting areas of the tree base. Upon pressing my hand lightly against a section of exposed tree phloem, the phloem cracked immediately and disintegrated with a light touch.

The tree is still leafing and appears alive and doesn't appear to be leaning significantly toward the picnic shelter it is located within 10 feet of. However, it is very obviously diseased, declining, structurally compromised, and located within a high enough traffic area with enough nearby target structures – and potential human targets using those structures – to make my concurrent recommendation for removal an easy determination to make.

I will add this recommendation to the file and fulfill this aspect of the City Staff Removal of Significant Public Trees application under Section 6.

I'm sharing a memo from Vance regarding the dead tree at The End of the Oregon Trail site. It's becoming a concern, and we're hoping to move ahead with removal once the permit is in place.

I hope this helps support the process. Please let me know if there's anything else you need from me to keep things moving.

Hi Brnadon.

I've inspected the alder tree next to the shelter, and it should be removed.

- The tree is in severe decline, with numerous conk mushrooms present—an indication of significant internal decay and likely structural failure.
- The deterioration is advanced enough that a blunt knife can easily penetrate the trunk up to 3 inches and I was surprised how easily a knife was able to penetrate it.
- Given its location next to a heavily used shelter and lawn area which is frequented daily by school groups and event attendees, this tree poses a serious safety risk and should be removed as soon as possible.
