In consideration of the granting of this permit to enter into and/or occupy the aforementioned right-of-way(s) the permittee, the group, the volunteer participants or their agents agree to release and discharge the City of Oregon City, its officers, City Commissioners, elected officials, employees and agents from any and all claims, actions, demands, and causes of action arising out of the work performed, the actions performing the work or the implementation of the terms of this permit.

Further, the permittee agrees to indemnify, hold harmless, and defend the City of Oregon City, its officers, City Commissioners, elected officials, employees and agents against all claims, actions and demands, and all expenses incidental to investigation and defense, arising from the permittee's use and occupancy of the City right-of-way.

All volunteers of the group or other person while engaged in the performance of any work or service under this agreement shall not be considered employees of the Transportation Division or the City of Oregon City and are not covered by the provisions of ORS 656 while performing the terms of this permit.
