#### 4.1 General

*The landscaping plan shall be prepared or reviewed by a landscape architect. Landscape architect approval is not required for tree removal and/or installation if the species are chosen from an approved street tree list. A certified landscape designer, arborist, or nurseryman shall be acceptable in lieu of a landscape architect for projects with less than 500 square feet of landscaping.*

### Perimeter Parking Lot Landscaping

*Perimeter parking lot landscaping is defined as the five-foot wide landscaped planter strip located on the perimeter of all parking lots located adjacent to the right-of-way and/or adjoining properties.*

*Building buffer landscaping is defined as the landscaping separating buildings onsite from the parking lot.*

*Parking areas shall be separated from the exterior wall of a structure, exclusive of pedestrian entranceways or loading areas, by one of the following.*

Includes an evergreen hedge screen of 30" height.

## Interior Parking Lot Landscaping

*Interior parking lot landscaping is defined as the landscaping located inside of the surfaced area used for on-site parking and maneuvering.*

Surface parking lots with more than 5 parking stalls shall include at least 45 sq ft of interior parking lot landscaping per parking stall.				
A minimum of 1 tree has been provided for every 4 parking spaces.				
A minimum of 1.5 shrubs has been provided for every parking space.				
No more than 8 contiguous parking spaces may be created without an interior landscape strip between them.
