



Public Involvement and Participation Approach

SWMP BMP Element #5

Purpose – to provide opportunities for the public to effectively participate in the development, implementation and modification of Oregon City's stormwater management program, as required by Schedule A.4.e of NPDES MS4 Discharge Permit, Number 101348, dated March 16, 2012.

General Information – this approach includes provisions for receiving and considering public comments on the monitoring plan due to the Oregon Department of Environmental Quality (DEQ) September 1, 2012, annual reports, stormwater management plan (SWMP) revisions, and the TMDL pollutant load reduction benchmark development.

General Expectations – the monitoring plan and annual reports will be provided to the public for review and comment on the City's website (www.orcity.org) prior to submission to DEQ. SWMP revisions and pollutant load reduction benchmarks (required for submittal to DEQ 180 days prior to permit expiration) will be made available on the City's website for a minimum of 30 days prior to submittal to DEQ.

Other Information – when posted on the City's website viewers will be directed to send comments to Oregon City's Water Quality Coordinator. Comments on the monitoring plan and annual reports will be collected and considered as part of the City's Adaptive Management Approach. Comments for SWMP revisions, and proposed pollutant load reduction benchmarks will be collected, considered, and response to comments will be publicly provided by posting on the Public Works NPDES web page.
