A speed zone investigation has been completed at the subject location and reports thereof are attached for your review and approval. This investigation was conducted in response to a request for an investigation from Dayna Webb, City Engineer, City of Oregon City. Dayna cites; "The posted speed limit on Glen Oak Road between Hwy 213 and Beavercreek Road is 35 mph. It does not appear that there is an issued speed zone order for this roadway authorizing a 35 mph speed limit. With the changes and growth this corridor has experienced over the past 20 years, the number of side street & driveways along the corridor, the recent addition of a city park and Oregon City High School athletic filed properties along the corridor, a request for ODOT to review the speed zoning seems appropriate".

Section A, from Cascade Highway (OR-213) to Beavercreek Road, is 0.97 mile in length. Context is suburban residential with heavy residential development. The roadway functional classification is urban major collector.

There are twelve intersecting streets in this section. Twelve are paved and eleven are controlled by a STOP sign.

Horizontal alignment contains four curves. Vertical alignment is mildly undulating with two crest and two sag curves.

The spot speed data for this section yields a 50<sup>th</sup> percentile speed of 32 MPH / 85<sup>th</sup> percentile speed of 36 MPH with 17% exceeding the existing 35 MPH (unestablished) zoning. The 2018-2020 crash rate is 0.24 with an ADT of 4,000 vehicles.

This office recommends establishing a 30 MPH speed zoning in this section. The recommendation was determined from OAR 734-020-0015 (2)(c)(B)(iii). The segment is contiguous to a residence district.




