GEOGRAPHIC SETTING: Occupies a large corner lot at the southwest corner of 15th and Taylor Streets. An entirely residential neighborhood. Nearest landmark building is a block away at 1508 - 16th Street (Hisel/Charriere House, 1912).

STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): Lee E. French was a laborer in Oregon City and a papermaker born in Oregon in 1879. This extremely simple house bridges the gap between Buene Vista vernacular farmhouse and the later bungalow style, right down to its simple corbelled chimney pot. Its original materials are intact and the site is not in any danger of encroachment.

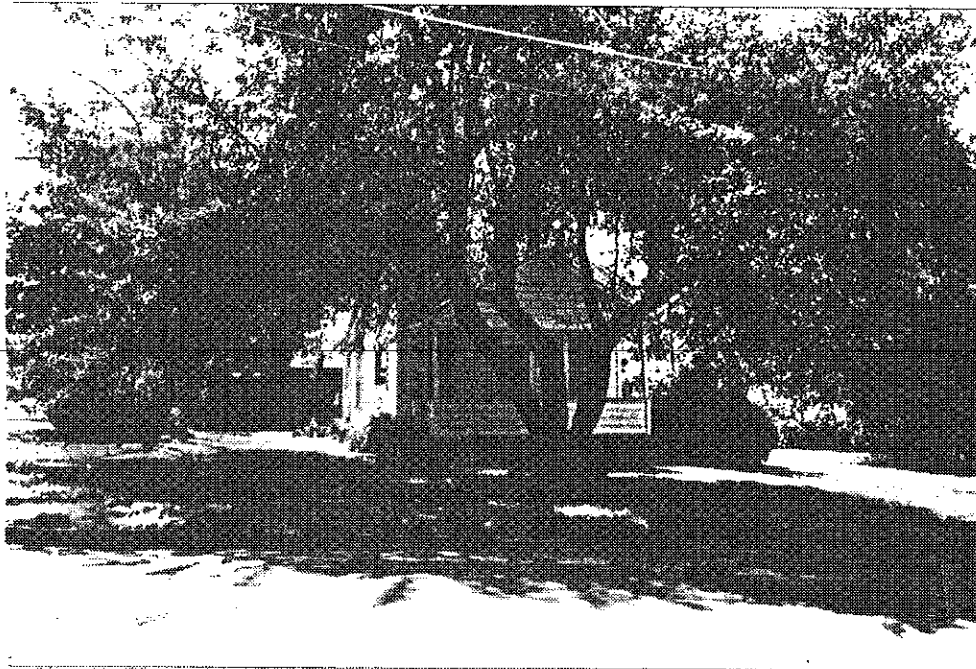

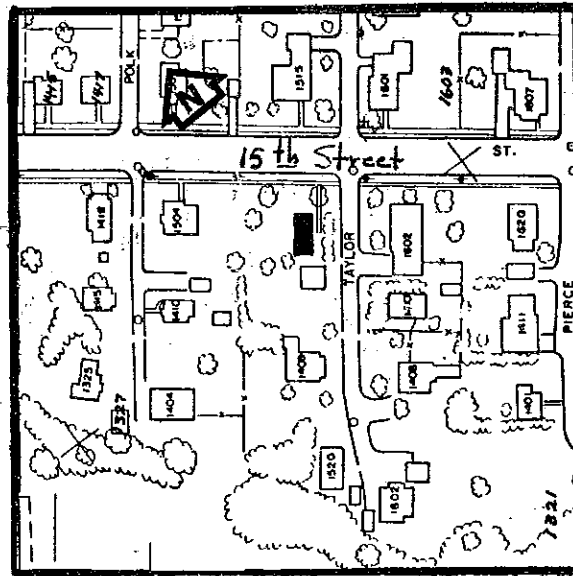
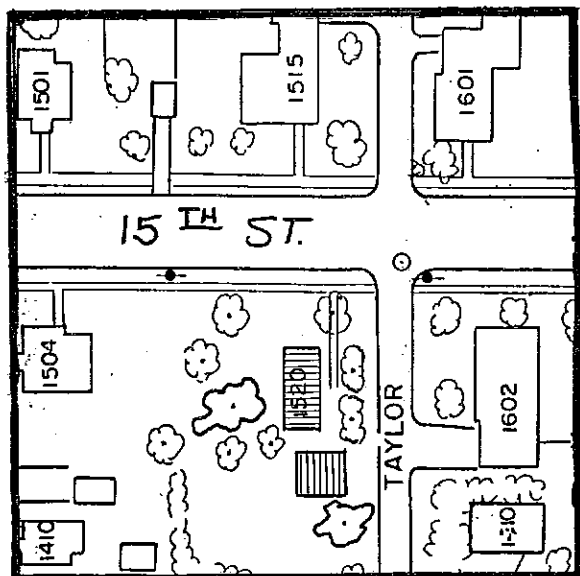
