GEOGRAPHIC SETTING: Although it is addressed as 18th Street, this house is located on a street identified as the "Main Street Extension", which leads to the industrial area behind the Oregon City Shopping Center. Nearby remaining structures include the Hackett House at 415 - 17th Street, and the Wood House at 309 - 17th Street.  
STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): No biographical information was found on Horace Williams, the original owner of the house. The house has significance for its age, although it is badly deteriorated. The house also has significance because it is one of the last remaining houses remaining in the area known as "Greenpoint", which was a residential area mostly destroyed by the construction of the freeway.





