GEOGRAPHIC SETTING: Well sited, high above street grade on a large corner lot at the intersection of 8th and Harrison Streets. The property abuts an unimproved alley. One block from busy 7th Street. Other landmarks in the area are kitty-corner at 1319 - 8th (Newman, c. 1904), and at 724 Polk Street (Fuge Residence, c. 1907).

STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): No biographical information was found on Mahlon Amrine, the original owner of the house. This well-sited bungalow has an unusual (but not unique) jerkinhead gabled porch. It stands out in the neighborhood because of its siting.





