GEOGRAPHIC SETTING: Occupies a corner lot at the northwest corner of 15th and Madison Streets. Across Madison Street are the Rivercliff Apartments. Only other landmark in the general vicinity is kitty-corner from this house, at 1422 Madison Street (Anton Naterlin House, c. 1913).

STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): John Naterlin was born in Austria in 1903. He was a fisherman while living in Oregon City. This house occupies a fairly good position above the main hill on 15th Street, and is a good example of the bungalow style.



