STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events,
persons, contexts): Sidney Nutall worked in the woolen mills as a young man. Later, he
became a pile driver for a Portland construction company, and worked on all the major
bridges in Portland (except Marquam and Fremont). His father was Edward Nutall (803
Fifth Avenue). This house is a typical Oregon City bungalow.





