STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): A later owner of this house was John Lyle, an overseer for the Oregon Worsted Company. This house is a World War II-era structure, and has no special significance to Canemah. Within the NR District, it is classified as a Compatible structure.



