GEOGRAPHIC SETTING: Located on a corner lot of Fourth Avenue at its intersection with Ganong Street. Hillside location. Lower side of Fourth Avenue. A heavily treed, residential area of Canemah.

STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): Charles Toole, born in 1863, was a woolsorter at the Oregon City Woolen Mill at the turn of the century. His wife, Sarah, was born in 1868 in England, and emigrated to the United States in 1884. They had seven children. The house is significant for its age; it is a typical vernacular structure for turn-of-the-century Oregon City. Within the Canemah NR District, it is classified as a Secondary structure.



